
KEY TASKS RESOLVED BY THE VOSTOK COMPANY

Our company suggests complex solutions in terms of automation of processes of quality control and records management for manufacturing enterprises using the state-of-the-art and the most popular tool, which is the Original Webrozum Web platform.

Implementation of automation at your enterprise is going to allow you to get the highest level of product protection, which is **an individ-ual e-passport (a serial number in the form of a QR code applied to each product unit, box or pallet).**

An **e-passport** provides an opportunity to track the route of the product from manufacturing to purchase and automatically detect counterfeit when the consumer scans the QR code with an ordinary smartphone.

For manufacturers, automation is going to allow them to significantly optimize the control and accounting of the manufactured products, and for wholesalers and retailers, to improve protection and trust in terms of the product brand and the enterprise, and, most importantly, to increase their sales and profit.



PROBLEMS OF THE BRANCH

Counterfeiting brands and packaging of the products is one of the most serious problems for manufacturing brands that damages both the image of the products and the brand of the manufacturer.

While working with our customers, we managed to discover the following problems in the branches of product manufacturers:

a. Counterfeit products and packaging: as a rule, visually differences are unremarkable (like "adidas" and "abibac" counterfeit products). Counterfeit products are not different on the outside and are sold allegedly under their own brand, while copying a well-known strong brand.

In this case, consumers do pay attention to brands, and most understand that those are counterfeit products, because they are usually cheaper.

b. Infringement is 1:1 copying of your brand applied to the product and packaging with your output data. In fact, this is theft, and consumers are sure that they buy branded products when they buy infringement ones.

Apart from damaging the brand, while the products may be of lower quality, the image of the manufacturer suffers as well and a significant part of the market is lost, and the manufacturers receive less than due (lose up to 50% profit) in some branches.





PROCESS AUTOMATION STRUCTURE

PRODUCTION AND LOGISTICS

Generation of e-registers of batches:

Formed as simple and understandable tables on the ORIGINAL WEBROZUM Web platform.

Product marking with QR codes:

Individual serial e-passports are created by marking individual and multi-unit packages (bags, boxes or pallets) with QR codes.

Control by the Quality Control Department, dispatching and quality certification:

Before dispatching, the QCD scans the finished products and provides the guarantees in terms of certified high-quality products.



ACCOUNTING AND MANAGEMENT

Central database and access:

- Creation and connection of automated workstations;
- Operative control and tracking the whole route of the products (from dispatching to the warehouse, from point A to point B);
- Accounting and reporting in terms of product batches;
- Opportunity to connect other software;
- Opportunity to control the processes at every stage.

Outlets:

- Outlet accreditation and control;
- · Control from anywhere in the world;
- Reports on the outlets;
- Sales reports in terms of various types of products, regions,
- seasonality, etc.

Manufacturing and sales planning:

- Momentary issuance of reports according to the set parameters; • Optimal manufacturing planning, considering all the factors and
- sales reports;
- Taking prompt and strategic decisions on the basis of the acquired information.
